

Special Awards Nomination Criteria

REALTOR® of the Year

PURPOSE OF THE AWARD: This special award is given to an active REALTOR® member of the Park City Board of REALTORS® who best exemplifies and promotes a positive REALTOR® image through the highest levels of service within the real estate community and the local community at-large. Involvement includes local, state, and national REALTOR® participation as well as active participation outside of the real estate industry. Longevity of Board membership, consistency of service, continuous participation, activities within the Board and in business as well as significant contributions to the real estate community will be considered when determining the recipient. This award will be given at the discretion of the Special Awards Committee and the Board of Directors. This award is not necessarily given annually. It may be given to a previous winner.

The following criteria will be considered:

- A. Nominee must have been in the real estate profession for at least three full years as of December 31st in the year for which they are nominated and must be a primary board member of the Park City Board of REALTORS®.
- B. Nominee must have had "active" participation in the Park City Board of REALTORS®. Active is defined as regular participation and attendance at the committee level as verified by PCBR staff. Active participation may also include involvement at the direction of the Board of Directors on special assignment or at the state or national level, and service as a volunteer Board instructor.
- C. Nominee must demonstrate active participation in the community, defined as ongoing service and/or contribution on the local level.

Affiliate of the Year

PURPOSE OF THE AWARD: This special award is given to an active affiliate member of the Park City Board of REALTORS® who is recognized by the membership for a commitment to excellent service in his or her respective field. Significant contributions to the real estate community will be considered when determining the recipient. This award will be given at the discretion of the Special Awards Committee and the Board of Directors. This award is not necessarily given annually.

The following criteria will be considered:

- A. Nominee must have been a member of the Board for at least twelve months as of December 31st in the year for which they are nominated.
- B. Nominee must have had "active" participation in the Park City Board of REALTORS®, which may include regular participation at Board events, sponsorship of Board events, and service on committees.

- C. Nominee must be deemed to enhance the quality of the real estate transaction experience, adhere to the Board's same standards of excellence, and provide essential local market expertise.

Meritorious Service Award

PURPOSE OF THE AWARD: This special award is given to an active member or members of the Park City Board of REALTORS® who contribute significantly to the community and/or Board, and thereby contribute to the REALTOR® image and the real estate industry in Summit and Wasatch Counties. This award will be given at the discretion of the Special Awards Committee and the Board of Directors. This award is not necessarily given annually.

The following criteria will be considered:

Nominee must have been a member of the Board for at least three years as of December 31st in the year for which they are nominated.

Community Service Award

PURPOSE OF THE AWARD: This special award is given to individuals or organizations that have contributed significantly to the community and thereby contribute to the real estate industry in Summit and Wasatch Counties. Nominees may include members of the public or members of the Board. This award will be given at the discretion of the Special Awards Committee and the Board of Directors. This award is not necessarily given annually.

Directors' Award:

This award is given at the discretion of the Board of Directors. This award may or may not be given each year. Qualifications for this award include but are not limited to the following:

1. Primary membership with the Park City Board of REALTORS®
2. Significant contributions to the real estate industry
3. Meritorious service to the real estate industry
4. Community involvement and service
5. Competency
6. Fairness and integrity
7. Professionalism
